## EXPLANATIONS

### Premium Discount for Intrusion Detection Systems

Since April 1<sup>st</sup>, 2015, we will offer a new discount for buildings not equipped with fire detection systems recognized by current Mutuelle programs. Today, our fire prevention programs allow us to help about half our members. With this new discount, we are pleased to announce that we will be able to reach all of them.

#### Eligibility Requirements

- The discount for Intrusion Detection Systems (“the System”) is offered to all eligible members of the Mutuelle;
- The discount applies to the entire “Property” section relating to the specific building(s);
- The following eligibility conditions must be met for each building:
  - The building and the System do not benefit from any other subsidy program offered by the Mutuelle (fire alarm systems).
  - All doors and windows that can be opened which are located less than 10 feet from the ground or a balcony are equipped with magnetic contacts or a motion sensor system installed nearby, inside the building.
  - The System is equipped with sirens inside and outside the building.
  - \*Optional\* The System is connected to a surveillance central station. *The relay to a central station is optional; however, it may entitle the insured to an additional premium discount.*
- In general, the insured commits to:
  - Making sure the System is functioning and running continuously upon closing of insured premises;
  - Maintaining the system in good operating condition at all times;
  - Bearing all costs related to the System such as acquisition, operating, maintenance and repair costs.
- The discount will be effective upon reception of the form by the Mutuelle. No discount will apply before April 1<sup>st</sup>, 2015.

#### How can I get a discount? It's as simple as 1-2-3!

1. Fill out a request for all specific buildings (a single form can be used for up to three buildings).
2. Once the request has been verified, we will send you a written confirmation.
3. The discount will be effective upon reception of the form by the Mutuelle. No discount will apply before April 1<sup>st</sup>, 2015.

#### ***Why offering a discount for Intrusion Detection Systems?***

Intrusions are the cause of a high number of disasters, including arson. By offering this new discount, we hope to encourage members to equip their property with an Intrusion Detection System and to support those who already have one. Intrusion Detection Systems are relatively inexpensive and are a highly efficient loss prevention tool.

#### ***Some of our buildings benefit from a subsidy through the biennial maintenance program. Are we eligible for this new discount?***

The buildings already benefiting from a current Mutuelle's program are not eligible for the new discount against intrusion. However, if you own several buildings, including at least one not affected by existing programs, you may receive a discount on the "Property Section" portion of the premium relating to the eligible building(s).
